



I will be contacting each of the Club Presidents and anyone else that I think can HELP!



DISTRICT 8 WINTER MEETING MINUTES

VENICE YACHT CLUB FEBRUARY 9, 2013

The District 8 Winter Meeting was held Saturday, February 9, 2013 at the Venice Yacht Club, Venice FL. This meeting was held in conjunction with the Winter Regional Meeting of the International Order of Blue Gavel. In attendance were approximately 50 members representing several District 8 Chapters, IOBG Executive Committee Members and others from different locations in the United States and Canada. Friday evening, IOBG members and some District 8 members had cocktails in Pearson's Cove with dinner and dancing in the Main Dining. There were 85 reservations for cocktails, dinner and dancing Saturday night.

At 1:00 PM, District 8 President George Eichman called the meeting to order and asked SEVP Lenworth Gordon to give the invocations and Charles Ranson, 1st VP District 8 to lead the Members in the Pledge Allegiance. President Eichman asked for a moment of silence for our men and women of the Armed Services.

Secretary Bud Higginson performed the Roll Call of the Executive Committee with George Eichman, Bert Gartenhaus, Charles Ranson, William Pittman, Bud Higginson, Robert Pease, Hal Bishop and Lenworth Gordon present. None were absent.

President Eichman asked each of the 50 meeting attendees to stand, state their name, Chapter and office held, if any.

A Roll Call was conducted by Secretary Higginson of the Chapter Presidents or their Designees of the Venice Y/C, Clearwater Y/C, Isles Y/C, Royal Palm Y/C, Vero Beach Y/C, Pelican Isle Y/C and Lighthouse Pt Y/C for a total of 114 votes. Proxies totaled 40 resulting in overall total votes of 154 out of 202 Members in good standing. 1/3 of the 202 equal 68 votes needed for a quorum. Secretary Higginson announced that we had a quorum and a motion was made to accept it.

Treasurer Robert Pease reported that the Balance as of November 1, 2012 was \$5,167.45. Income total of \$2,955.50 and Expense total of \$873.30 resulted in a balance as of February 9, 2013 of \$7,249.65. Treasurer Pease presented a Budget for the period November 1, 2012 —October 31, 2013 of \$11,800.00 Total Income and \$11,800.00 Total Expense resulting in an Operating Gain/Loss of \$0.

President Eichman announced that he had asked Charles Ranson to assist President Elect Bert Gartenhaus on the Membership Committee. P/E Gartenhaus reported that he and Hal Bishop have been working on the Membership Development Plan and would have it ready shortly. He also discussed the fact that he has made contact with 4 different Yacht Clubs, speaking with their officers and asking them to join the IOBG.

Second VP Pittman reported on the Special Project of Identifying Chapter sponsored events which advance Club's value to their membership. He reviewed the Survey form that is to be e mailed to all Chapter Presidents after it is approved. President Eichman asked that a copy be sent to the Executive Committee for their comments. Co-Chair Bud Higginson explained as an example what the Venice Yacht Club Chapter IOBG did last year when they sponsored three Saturday Night Events including Raffling off three donated prizes raising \$4000 that was used to purchase unbudgeted kitchen items and table linens for their club.

Acting Supply Officer Lenworth Gordon stated that all orders have been filled and that he has the supplies setup in the rear of the room for if anyone needed anything after the Meeting. President Eichman discussed the possibility of each member dealing direct with Commodore Insignia for their requirements and do away with the Local Supply function. It was brought up that Commodore Insignia does not want to deal with everyone, it wants on one person to deal with in an organization. Further thought into this matter is needed before proceeding.

President Eichman reviewed the major projects he would like to accomplish this year. The first be Electronic Communication. The system is up and running. To date, he reported that only 50% of the District 8 members opened their email and the goal now is to somehow encourage members to check their email. He further discussed the plan to produce and distribute our Gulf Stream publication electronically after the last hard copy is produced this quarter; however, due to the accident of P/P Harvey Sussel, our editor, we will not have a hard copy produced. President Eichman is working with Mary Nye Meyers and will have an electronic edition sent out within a couple of weeks.

Second on President Eichman's list is Membership Development where Bert Gartenhaus and Hal Bishop along with the assistance of Charles Ranson are working on a plan which should be forth coming in a short period of time. The Special Projects co-chaired by Bill Pittman and Bud Higginson are in the final stages with surveys being mailed out to Chapter Presidents and the combined results being distributed to all active and inactive Chapters in the hope some inactive Chapters may become active again.

For the Good of the Order, President Eichman asked members for any comments.—P/P Harvey Sussel is recovering well from his accident and surgery—P/P Art Theobold had a stroke earlier in the week and was in Cape Coral Hospital---Frank Hutchinson is on oxygen and not doing well---P/P Ray Thompson's wife in Rehab in Orlando.

The next District 8 meeting will be held on Saturday, June 1st, 2013 at the Clearwater Yacht Club in Clearwater, FL.

President Eichman adjourned the meeting at 1:50 PM.

District Supply Officer Lenworth Gordon

We have filled quite a few orders in 2013, although I think we can do much more for special orders. It seems as if members are not aware of uniform protocol how and from where they should place their orders. These are some of the reasons why we appoint a supply officer. We may place orders directly with Commodore Insignia for example, and if they will allow it, but they as well as IOBG International, discourages that process to ensure that only those who are authorized will receive and wear the IOBG insignias.

I have accepted this position in order to develop a simple process for ordering supplies and to bring up to date the pricing schedule for the District. Some changes have been made to the pricing for basic insignia items, and I have attached the following price list to help us moving forward. The District at this time is absorbing the mailing costs from the distributer to us using the discount offered by the supplier. The mailing costs for delivering to individuals and clubs are added to invoices and passed on to recipients as required by the Postal Service.

Items such as uniform shirts and other apparel with or without insignia are available as requested, and prices will be furnished as the supplier responds. Currently, the supply officer has a petty cash bank of \$300.00 to process orders as they come in. In time, I will furnish an inventory of the ships store then forward for approval, a list of items I think prudent to keep in stock for immediate purchase at business meetings or for immediate delivery upon request.
